

AFFIDAVIT OF CULTURAL EXEMPTION TO VACCINATION

"Council Of Affairs for Naturally Occurring Autochthons" CANOA is governed by and composed of a National association of Naturally Occurring Autochthonous, Aboriginal Clan Mothers and Chiefdom Councils for the affairs of Naturally Occurring Autochthonous Aboriginal Americans a.k.a. American Indians.

CANOA was founded to advocate for natural and comprehensive social, political, economic health and well being of the Aborigine American Indian a.k.a as Indian, according to the United States Constitution, Article 1, Section 2, Clause 3, "And excluding Indians not taxed"...

Therefore, we affirm that mandated vaccinations are an unlawful act, contrary to our social, political and cultural and natural inalienable existence, that being "time immemorial". Our objections to such and all vaccinations is within our natural right to continue to exist uninhibited as indigenous beings under international human right treaties Included in the Articles of the "American Declaration on the Rights of indigenous People" (ADRIP):

Article XI. Protection against genocide. Indigenous people have the right not to be the object of any Form of genocide or attempts to exterminate them.

Article XVIII. Health: (3) States shall take measures to prevent and prohibit indigenous peoples and Individuals from being subjects of research programs, biological or medical experimentation, or Sterilization without their * free, prior, and informed consent. Likewise, indigenous peoples and Individuals have the right, as appropriate, to access to their data, medical records, and documentation of Research Conducted by individuals and institutions, whether public or private.

And Furthermore:

Article XIX. Right to protection of a healthy environment: (1) Indigenous peoples have the right to Live in harmony with nature and to a healthy, safe and sustainable environment, essential

conditions for The full enjoyment of the rights to life and to their spirituality, cosmovision, and collective well-being;

(3) Indigenous people have the right to be protected against the introduction, abandonment, dispersion, Transit, indiscriminate use, or deposit of any harmful substance that could adversely affect indigenous Communities, lands, territories, and resources.

We, the Council Of Affairs for Naturally Occurring Autochthons, assert that our decision to abstain from vaccinations is in accordance with national and international Laws pertaining to our free power of choice respective of our right to informed consent as defined in The Nuremberg Code whereas:

We will not be subject to any element of force, fraud, deceit, duress, coercion, overreaching, or other ulterior forms of constraint for our decision.
